1. INVESTMENT OPTIONS

A. Fishless Investor

- Minimum Investment: \$500

- Maximum Investment: \$2,000

- Return on Investment (ROI): 3%

- Investment Duration: 3 Months

B. Cropped Investor

- Minimum Investment: \$2,000

- Maximum Investment: \$5,000

- Return on Investment (ROI): 5%

- Investment Duration: 6 Months

C. Pro Investor

- Minimum Investment: \$5,000

- Maximum Investment: \$10,000

- Return on Investment (ROI): 7%

- Investment Duration: 9 Months

2. SECURITY AND FUND PROTECTION

- The Company ensures that all investments are managed with high-level encryption, secure wallets, and insurance against cyber threats.
- Investors' funds are protected under international investment laws and governed by the Danish Financial Supervisory Authority.
- Regular updates and reports will be provided to investors for transparency and accountability.

3. RETURNS AND PAYOUTS

- Returns shall be paid at the end of the investment duration unless otherwise agreed in writing.
